They have lots of questions — and they are helped by the people who work where they live.



This story can help you too!

You will learn:

- what **the asylum procedure** means
- what to expect
- why it is necessary for you to participate and work with the officers
- who can help you
- about your rights

Take your time. It's OK to stop and come back to it later.

If something is hard to understand, **ask for someone to explain it to you.**
Your guardian, social worker or lawyer can help you.

For people **below 18 arriving alone**, a guardian will be appointed. In some countries, the guardian is also called a representative.

Also, in some countries, **asking for asylum** is called **asking for international protection**.



Lastly, be aware that all services offered at the reception facilities where you are staying are free. If a staff member asks you for money, talk to an officer you trust or your guardian.

I am 24 years old. I arrived together with my brother, Ahmed, who I take care of as best I can. We arrived recently and are trying to join our uncle who has been living in Europe for some time. I love sports and I am very good at playing football.



Adam

I am 9 years old. I am here on my own.
For now, I have decided not to speak.
I experienced many bad things before arriving here. I need some time before I will talk again.
But I am smart and I understand everything. I am a very good listener and want to go to school.
I like all the new friends I have made so far.



Ms Ines

I am a guardian working in this reception centre. I try to support all children and young people seeking asylum as best I can. I love cooking and it makes me happy when everyone is busy and active. Exercise keeps us all physically and mentally healthy.



Mr Fred

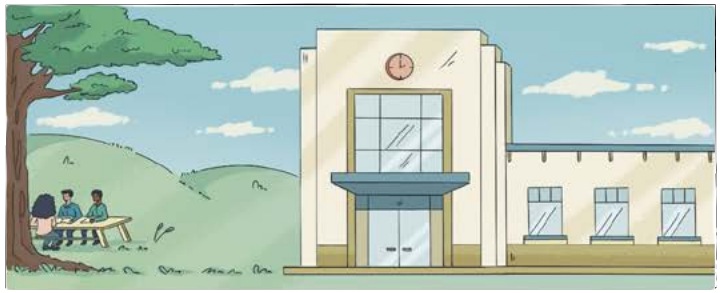
I am a legal counsellor, which is a type of lawyer. I work here together with many well-trained colleagues.

Thanks also goes to the authorities in Malta and the Netherlands who supported the discussions with the teenagers.



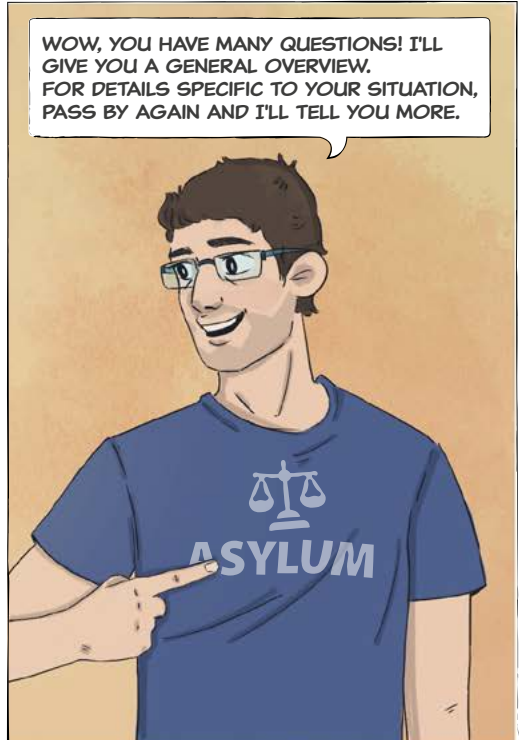

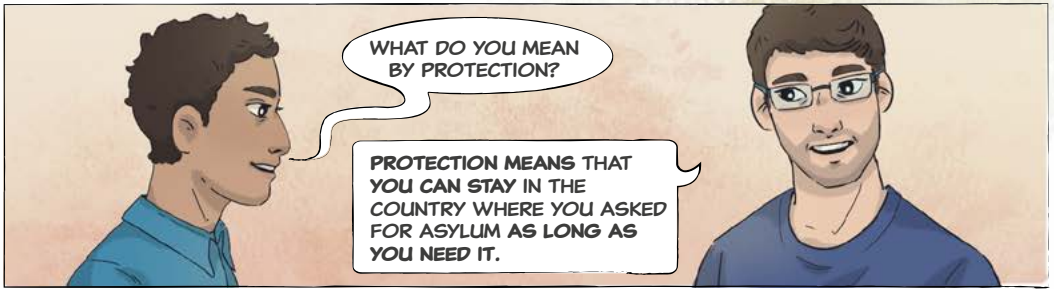
... AND ONCE YOU RECEIVE A DECISION...





IF YOU CANNOT GO BACK TO YOUR COUNTRY BECAUSE IT IS UNSAFE FOR YOU, YOU CAN ASK FOR ASYLUM.

WHILE EVERYONE HAS THE RIGHT TO ASK FOR ASYLUM, NOT EVERYONE WILL RECEIVE PROTECTION.



WHAT DO YOU MEAN BY PROTECTION?

PROTECTION MEANS THAT YOU CAN STAY IN THE COUNTRY WHERE YOU ASKED FOR ASYLUM AS LONG AS YOU NEED IT.



WHETHER OR NOT YOU RECEIVE PROTECTION DEPENDS ON THE REASONS YOU BELIEVE YOUR HOME COUNTRY IS NOT SAFE FOR YOU. FOR EXAMPLE...

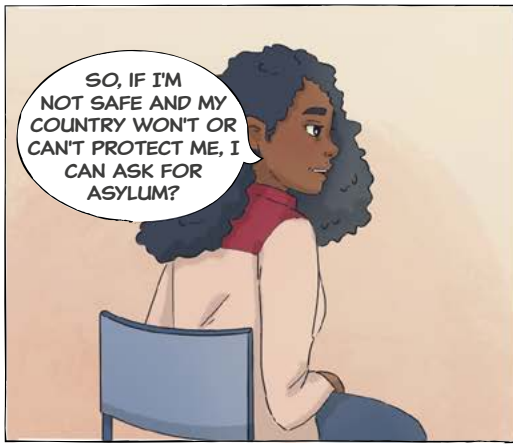
- If you are afraid to return because of:
- your skin colour
- your religion, culture or the traditions you practice
- your ethnic group
- your political views or those of your family
- the person you love and want to be with
- a group you belong to that is not accepted



... MOREOVER, YOU MAY ALSO RECEIVE PROTECTION IF THERE IS WAR IN YOUR COUNTRY OR YOU WOULD FACE OTHER VIOLENT TREATMENT IF YOU RETURN.



THESE ARE SOME SITUATIONS THAT CAUSE PEOPLE FLEE THEIR COUNTRIES.



SO, IF I'M NOT SAFE AND MY COUNTRY WON'T OR CAN'T PROTECT ME, I CAN ASK FOR ASYLUM?



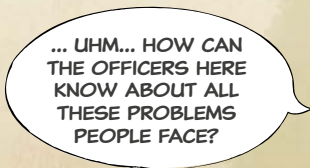
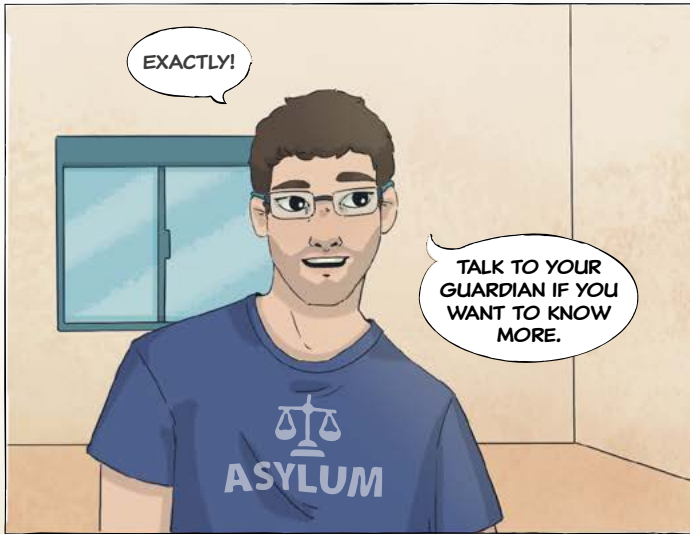
EXACTLY!

IN SOME COUNTRIES, BEING A GIRL CAN BE RISKY AS GIRLS CAN'T MOVE FREELY, MAY BE BANNED FROM SCHOOL OR ARE FORCED INTO MARRIAGE, WHILE...



... IN OTHER COUNTRIES, PEOPLE MIGHT BE AT RISK DUE TO A HEALTH CONDITION OR A DISABILITY THEY HAVE.





THE OFFICERS WILL ASK YOU MANY QUESTIONS TO LEARN AS MUCH AS POSSIBLE ABOUT YOU. SHARE YOUR STORY.



ALSO, ANYONE UNDER 18 AND ARRIVING ALONE SHOULD TELL THE OFFICERS IMMEDIATELY SINCE CHILDREN NEED MORE SUPPORT THAN ADULTS.

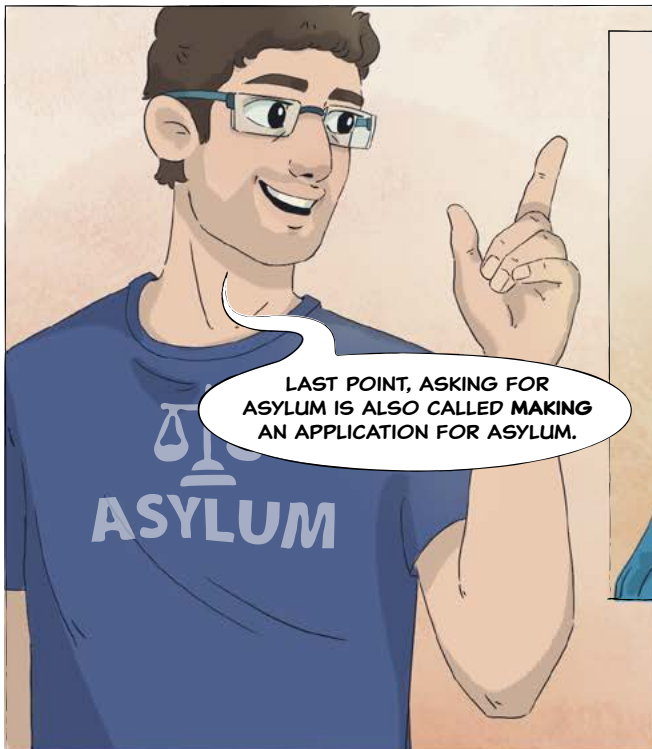


THEN, A TEMPORARY GUARDIAN WILL BE ASSIGNED TO YOU. WITHIN 3 WEEKS OF ASKING FOR ASYLUM, A PERMANENT GUARDIAN WILL BE APPOINTED TO SUPPORT YOU.

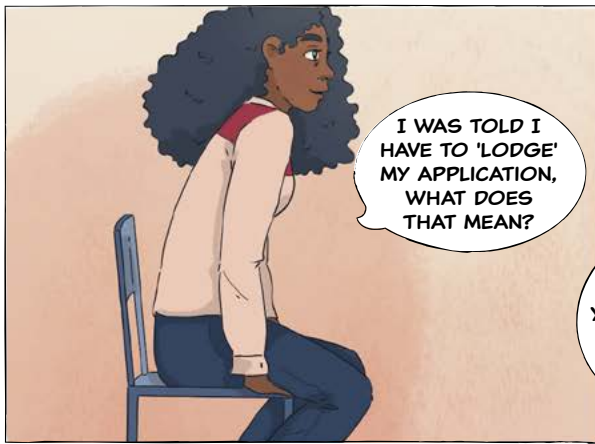
THE OFFICERS TALKING TO YOU ARE TRAINED AND WILL TRY THEIR BEST TO COMFORT YOU.

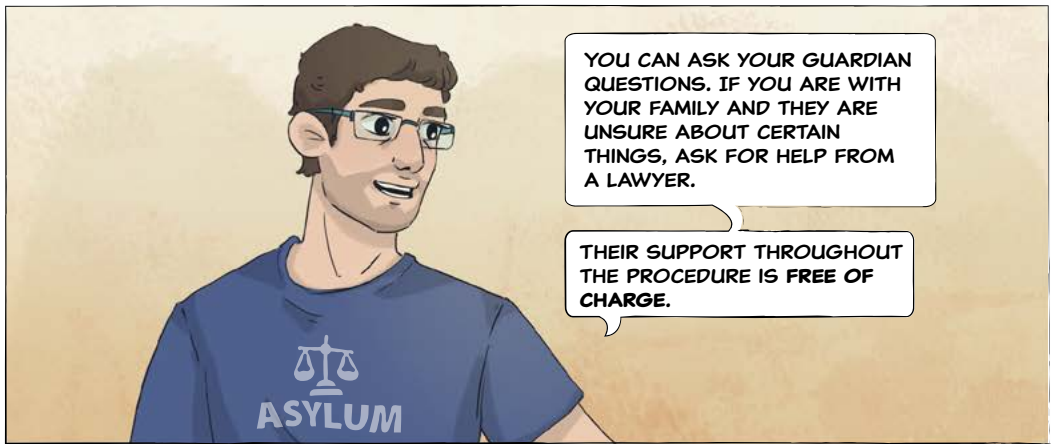
THEY TRY TO CONSIDER YOUR WISHES, NEEDS AND CONCERNS BEFORE MAKING IMPORTANT DECISIONS. THEY ALSO READ ABOUT YOUR COUNTRY TO BETTER UNDERSTAND YOUR SITUATION.











YOU CAN ASK YOUR GUARDIAN QUESTIONS. IF YOU ARE WITH YOUR FAMILY AND THEY ARE UNSURE ABOUT CERTAIN THINGS, ASK FOR HELP FROM A LAWYER.

THEIR SUPPORT THROUGHOUT THE PROCEDURE IS FREE OF CHARGE.



AFTER I WAS REGISTERED, I WAS GIVEN A DOCUMENT SAYING I AM AN APPLICANT.



YES. THIS DOCUMENT SHOWS THAT YOU APPLIED FOR ASYLUM. IT IS IMPORTANT. KEEP IT SAFE.




I TOOK A PHOTO OF MINE AND SAVED IT ON MY PHONE...




WELL DONE!



MR FRED, MY GRANDFATHER IS HERE IN EUROPE. NOW THAT I'M AN APPLICANT, CAN I TRAVEL TO JOIN HIM?




NOT YET. STAY WHERE YOU'RE REGISTERED. THE AUTHORITIES, TOGETHER WITH YOU AND YOUR GUARDIAN, WILL DECIDE IF AND HOW TO REUNITE YOU WITH HIM.




...ALSO, TRAVELLING ALONE CAN BE DANGEROUS!



I UNDERSTAND I HAVE TO STAY HERE.



WHILE WAITING FOR THEIR ASYLUM INTERVIEW, WHERE DO PEOPLE SLEEP AND EAT?



THE AUTHORITIES MUST GIVE YOU A SAFE AND SUITABLE PLACE TO STAY CALLED RECEPTION. THEY'LL EXPLAIN HOW YOU GET FOOD AND ESSENTIALS.

NORMALLY, CHILDREN WITH FAMILIES STAY IN FAMILY HOUSING.



CHILDREN ON THEIR OWN MAY BE PLACED WITH OTHER CHILDREN IN A SIMILAR SITUATION AND DEPENDING ON THEIR NEEDS.

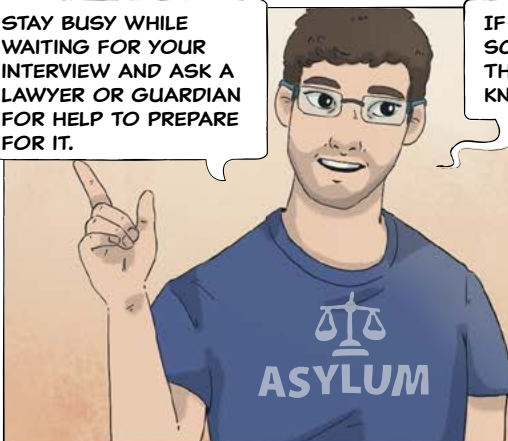
THE OFFICERS WILL INFORM YOU WHERE YOU CAN LEARN THE LOCAL LANGUAGES...



... ATTEND SCHOOL, FIND WORK OR SEE A DOCTOR IF NEEDED.



STAY BUSY WHILE WAITING FOR YOUR INTERVIEW AND ASK A LAWYER OR GUARDIAN FOR HELP TO PREPARE FOR IT.



IF YOU FEEL WORRIED, STRESSED OR SCARED, TELL SOMEONE YOU TRUST. THE OFFICERS CAN ONLY HELP IF THEY KNOW WHAT WORRIES YOU.



YOU, YOUR GUARDIAN OR CAREGIVER WILL RECEIVE A WRITTEN INVITATION FOR THE INTERVIEW WITH THE DATE, TIME AND PLACE, BY EMAIL OR POST.



CHILDREN MUST BE INTERVIEWED WITH AN ADULT RESPONSIBLE FOR THEM, LIKE A PARENT OR GUARDIAN.



WHAT HAPPENS IF I'M SICK ON THAT DAY?

YOU OR YOUR GUARDIAN HAVE TO INFORM THE AUTHORITIES IMMEDIATELY.



UHM... WHAT HAPPENS DURING THE ASYLUM INTERVIEW?

DURING THE INTERVIEW, A PERSON CALLED A 'CASE OFFICER'...

WILL ASK YOU QUESTIONS ABOUT YOUR FAMILY, LIFE AT HOME, THE SECURITY SITUATION THERE, WHY YOU LEFT AND YOUR JOURNEY. EVERYTHING YOU SAY IS CONFIDENTIAL, MEANING IT IS NOT SHARED WITH ANYONE.

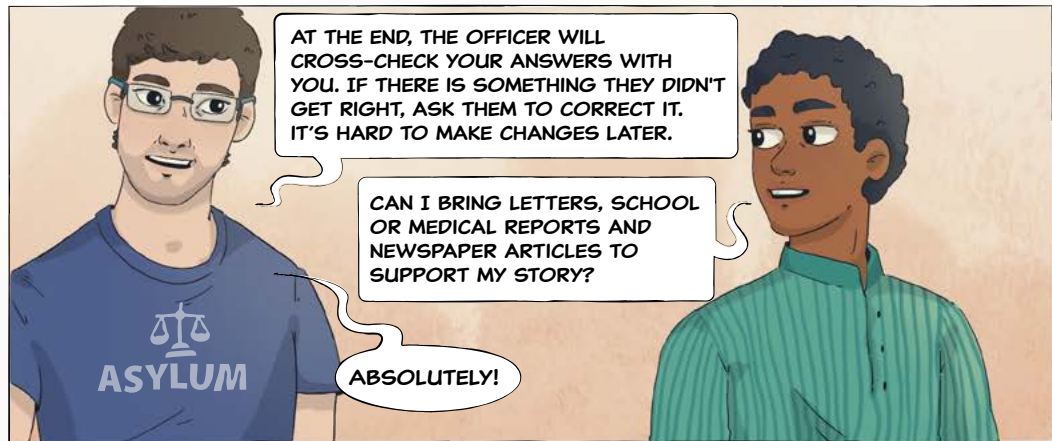

TIME OR NEAR A HOLIDAY.

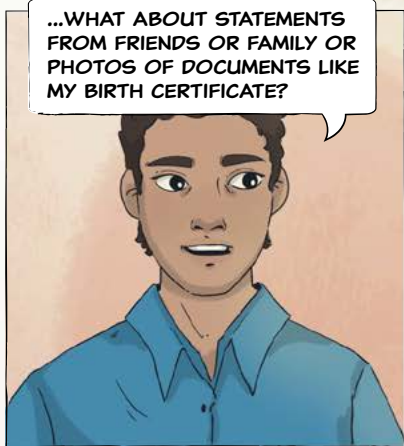
JUST DON'T MAKE

AT THE END, THE OFFICER WILL CROSS-CHECK YOUR ANSWERS WITH YOU. IF THERE IS SOMETHING THEY DIDN'T GET RIGHT, ASK THEM TO CORRECT IT. IT'S HARD TO MAKE CHANGES LATER.

CAN I BRING LETTERS, SCHOOL OR MEDICAL REPORTS AND NEWSPAPER ARTICLES TO SUPPORT MY STORY?

ABSOLUTELY!



...WHAT ABOUT STATEMENTS FROM FRIENDS OR FAMILY OR PHOTOS OF DOCUMENTS LIKE MY BIRTH CERTIFICATE?

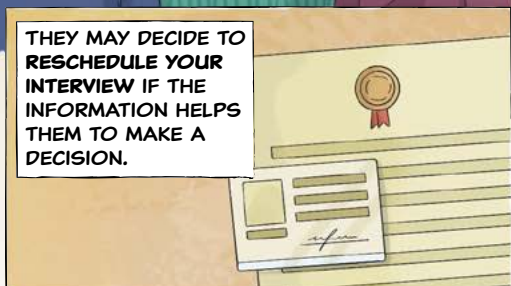


YES, AS LONG AS IT IS RELEVANT TO EXPLAIN YOUR STORY AND WHY YOU HAD TO LEAVE.

FRIENDS AND FAMILY CAN HELP ME FIND THIS INFORMATION.



YES, BUT THEY SHOULD NOT PUT THEMSELVES AT RISK. TELL THE OFFICERS IF YOU NEED MORE TIME.



THEY MAY DECIDE TO RESCHEDULE YOUR INTERVIEW IF THE INFORMATION HELPS THEM TO MAKE A DECISION.



A FRIEND SAID THE AUTHORITIES WON'T REVIEW HIS ASYLUM APPLICATION. WHY IS THAT?



THE AUTHORITIES FIRST CHECK IF THEY NEED TO EXAMINE AN ASYLUM APPLICATION OR NOT.



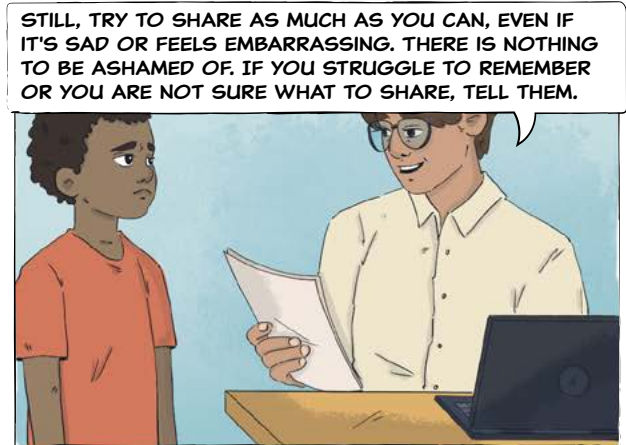
THEY MIGHT NOT DO SO IF YOU HAVE ALREADY RECEIVED PROTECTION IN ANOTHER COUNTRY OR IF YOU COME FROM A COUNTRY THAT THEY CONSIDER SAFE.



MR FRED, WHAT IF SOMEONE WANTS TO ANSWER BUT CAN'T—MAYBE BECAUSE THEY'RE SCARED OR THE QUESTIONS ARE TOO PERSONAL?



THAT'S DIFFERENT. PEOPLE FLEE BECAUSE OF VERY BAD EXPERIENCES. IT'S NATURAL TO NOT WANT TO TALK ABOUT IT.



STILL, TRY TO SHARE AS MUCH AS YOU CAN, EVEN IF IT'S SAD OR FEELS EMBARRASSING. THERE IS NOTHING TO BE ASHAMED OF. IF YOU STRUGGLE TO REMEMBER OR YOU ARE NOT SURE WHAT TO SHARE, TELL THEM.

WHAT YOU EXPERIENCED CAN BE IMPORTANT INFORMATION. THE OFFICERS WILL TRY TO COMFORT YOU. THEY MIGHT PAUSE OR ASK SOMEONE TO JOIN TO SUPPORT YOU IF THEY SEE YOU'RE STRUGGLING.



EVERYONE WORKING HERE MUST TREAT YOU WITH RESPECT. IF THEY DON'T, YOU CAN OFFICIALLY COMPLAIN—ASK SOMEONE YOU TRUST TO HELP YOU.

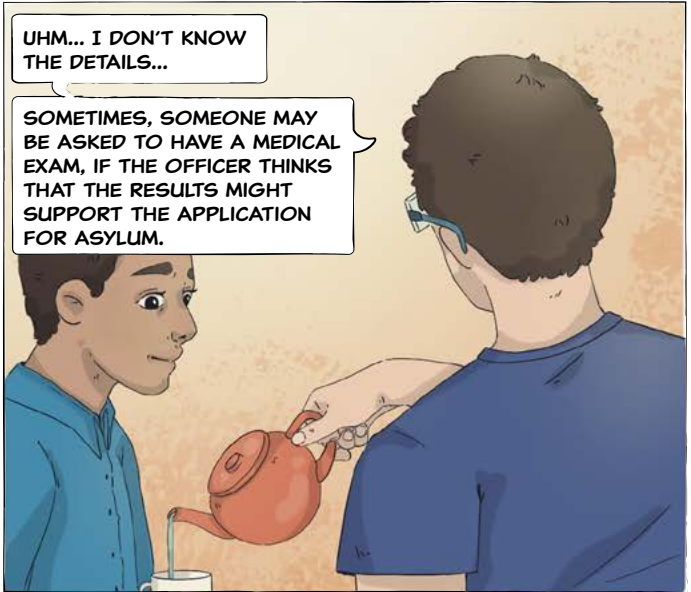


A FRIEND'S PERSONAL ASYLUM INTERVIEW WAS STOPPED AND HE WAS ASKED TO SEE A DOCTOR. WHY?



UHM... I DON'T KNOW THE DETAILS...

SOMETIMES, SOMEONE MAY BE ASKED TO HAVE A MEDICAL EXAM, IF THE OFFICER THINKS THAT THE RESULTS MIGHT SUPPORT THE APPLICATION FOR ASYLUM.



MAYBE THE PERSON HAS A HEALTH OR MENTAL HEALTH PROBLEM THAT WASN'T NOTED BEFORE AND NEEDS TREATMENT. DEPENDING ON THE RESULTS, THE NEXT STEPS WILL BE DECIDED.



THE OFFICERS WILL ASK IF YOU AGREE TO DO THE EXAM. AS A CHILD, YOUR PARENTS OR THE GUARDIAN WILL BE INVOLVED.



UHM... HOW DO I KNOW IF I AM GIVEN ASYLUM OR NOT?



AFTER THE INTERVIEW, THE OFFICERS WILL REVIEW ALL THE INFORMATION AND REACH A DECISION ON YOUR APPLICATION. IT CAN TAKE TIME BEFORE YOU GET A LETTER EXPLAINING THE DECISION.



UNDERSTOOD. THAT'S WHY THEY WANTED MY UPDATED PHONE NUMBER AND ADDRESS, SO THEY CAN REACH ME.



YES! IF THE DECISION IS POSITIVE, PEOPLE CAN STAY AND RECEIVE A FORM OF PROTECTION.



THIS CAN BE REFUGEE STATUS, RIGHT?

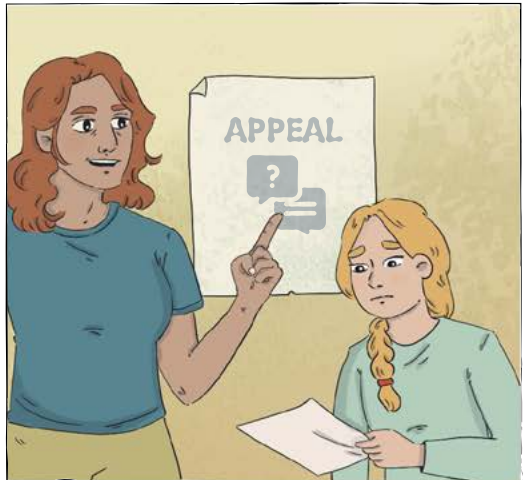


YES! ...OR SUBSIDIARY PROTECTION.



IN BOTH CASES, YOU GET A RESIDENCE PERMIT TO STAY HERE AS LONG AS YOU NEED PROTECTION. A LAWYER CAN EXPLAIN THE DETAILS TO YOU.

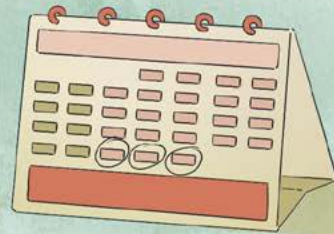
IF YOU RECEIVE A NEGATIVE DECISION, YOU CANNOT STAY BECAUSE IT WAS DECIDED THAT IT'S SAFE FOR YOU TO GO BACK TO YOUR HOME COUNTRY OR TO THE COUNTRY WHERE YOU LIVED BEFORE.




IF YOU DISAGREE, YOU CAN APPEAL, WHICH MEANS ASKING FOR YOUR CASE TO BE LOOKED AT AGAIN.



YOU WILL HAVE TO FILL IN THE FORMS RIGHT AWAY. ASK FOR HELP. REMEMBER, AN APPEAL IS ONLY A REVIEW, NOT A GUARANTEE FOR PROTECTION.






THE RETURN PROCEDURE IS FOR THOSE WHO MUST GO BACK SINCE THEIR COUNTRY IS CONSIDERED SAFE.



SOME PEOPLE MIGHT ALSO CHOOSE TO RETURN VOLUNTARILY. INFORM THE OFFICERS TO GET SUPPORT.




THE BORDER PROCEDURE MEANS THAT YOUR ASYLUM APPLICATION IS EXAMINED WHERE YOU ARRIVED BY AIR, LAND OR SEA.



YOU MAY HAVE TO STAY THERE UNTIL YOUR CASE IS DECIDED AND YOU CAN'T MOVE FREELY.

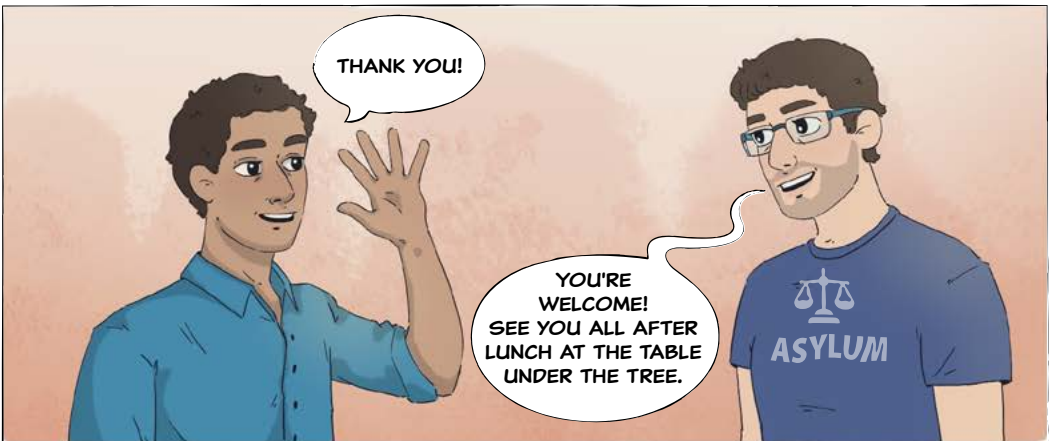
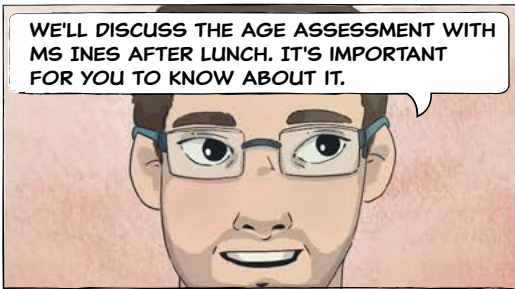


CHILDREN ARRIVING WITH FAMILY MAY STAY IN THE BORDER PROCEDURE, WHICH LASTS 3 TO 4 MONTHS.



CHILDREN ARRIVING ALONE DON'T GO INTO THE BORDER PROCEDURE, HOWEVER, THERE ARE A FEW EXCEPTIONS.
